Explanation of Responses:

- On February 22, 2017 the reporting person was granted 12,000 Restricted Stock Units vesting on the first anniversary of the grant date.
- This award has no expiration date. Units will either vest or be forfeit.
- These shares were omitted from the reporting person's original Form 3, and also were omitted from one Form 4 filed by the reporting person after his original Form 3 was filed.
- Each Restricted Stock Unit represents a contingent right to receive one share of STKL common stock.
- The grant cliff vests after 3 years on May 24, 2020.
- These shares were omitted from the reporting person's original Form 3.
- On May 24, 2017 the reporting person was granted 12,497 Restricted Stock Units, vesting in three equal annual installments beginning on the first anniversary of the grant date.
- The Performance Stock Units will vest, if at all, on May 24, 2020 based upon meeting the following stock performance conditions for 20 consecutive trading days: one-third of the Performance Stock Units eligible to vest upon achieving a stock price of \$11.00, one-third of the Performance Stock Units eligible to vest upon achieving a stock price of \$14.00, and one-third of the Performance Stock Units eligible to vest upon achieving a stock price of \$18.00.
- Each Performance Stock Unit represents a contingent right to receive one share of STKL common stock.
